#### **ORAL JUDGMENT:**

- 1. Rule. Rule made forthwith with consent of both the parties.
- 2. The caste claim of the Petitioner as belonging to the Koli Mahadev, Scheduled tribe is invalidated.
- Learned counsel for the Petitioner submits that even the documents 3. of the years 1950, 1938 in the record of the grandfather and great grandfather of the Petitioner records caste as 'Mahadev Koli'.
- 4. Learned counsel submits that Vigilance Cell has not found any interpolation in the old record. Learned counsel submits that preconstitutional documents have more probative value.
- 5. Learned counsel further submits that the affirmity test is not a

litmus test. Reliance is placed on the judgment of the Apex Court in case of *Anand V/s Committee for Scrutiny and Verification of Tribe Claims and Ors.* reported in 2012 (1) SCC 113.

- 6. Learned AGP submits that that the school record of the father of the Petitioner is interpolated. In the caste column, the caste Hindu Koli is stroked and Mahadev Koli has been inserted. So far as the birth record of the great grandfather of the Petitioner is of the year 1929, the same does not find place and the caste is written in different ink and handwriting. The day mentioned is 18/02/1929 and there is no page number on it. Looking at birth record of the year 1934 of Dattu Babaji, it appears that Mahadev Koli caste is written in different handwriting and different ink. The Petitioner has also failed in Affirmity test.
- 7. We have considered the submissions. The Petitioner has relied upon the following documents which has been considered by the Vigilance cell also:-

8. Except the document of the year 1981 of the father, the vigilance

has found the other entries in the caste column of the Petitioner's

grandfather and great grandfather to be as 'Mahadev Koli' and no

interpolation has been found in the said documents.

9. The documents of the grandfather and great grandfather of the

Petitioner recording caste as 'Mahadev Koli' are pre-constitutional

documents having more probative value.

10. Affirmity test is not a litmus test as observed by Apex court in case

of Anand (supra), in view of consistent old record recording caste as

'Mahadev Koli' in the school record and birth record of the Petitioner's

grandfather and great grandfather, we are inclined to consider the case of

the Petitioner.

11. In light of the above, the impugned judgment is quashed and set

aside. The Committee shall issue validity certificate to the Petitioner of

Koli Mahadev, Scheduled tribe preferably within three weeks.

12. Rule accordingly made absolute. Writ petition is disposed of. No

costs.
