MAHARASHTRA SCHEDULED CASTES, SCHEDULED TRIBES, DE-NOTIFIED TRIBES (VIMUKTA JATIS), NOMADIC TRIBES, OTHER BACKWARD CLASSES AND SPECIAL BACKWARD CATEGORY (REGULATION OF ISSUANCE AND VERIFICATION OF) CASTE CERTIFICATE ACT, 2000 (MAH. XXIII. OF 2001.)

No. STC.2119/34/Desk 10.- In Exercise Of The Powers Conferred By Sub-Section (1) Of Section 6 Of The Maharashtra Scheduled Castes, Scheduled Tribes, De-Notified Tribes (Vimukta Jatis), Nomadic Tribes, Other Backward Classes And Special Backward Category (Regulation Of Issuance And Verification Of) Caste Certificate Act, 2000 (Mah. XXIII. Of 2001.) and in supersession of Notification Tribal Development Department, No. STC.2119/34/Desk 10, dated the 19th March 2021 and the orders and instrument issued in this behalf, the Government of Maharashtra hereby reconstitute the following Scrutiny Committees and specify the functions and the area of their jurisdiction for the purposes of the said Act as follows, namely :-
